

# Pedophiles Under Attack in the Netherlands

This document attempts to paint a picture, for our foreign peers, of what it is currently like to be pedophile - particularly a pro-pedo activist - in the Netherlands.

## Prevailing trend

Per October 2002, the age of consent of 12 (subject to qualifications) was raised to 16.<sup>1</sup> Per January 2010, accessing child pornography - even without possession - was outlawed.<sup>2</sup> The "Wet seksuele misdrijven" adds restrictions to sexual interactions with 16- and 17-year-olds, and illegalizes certain 'sex chats'.<sup>3</sup>

On 2 April 2013, an appellate court upheld the right to freedom of association of (pedophile) association Vereniging Martijn.<sup>4</sup> Six days later, on 8 April, while standing next to Dutch Prime Minister Mark Rutte during a press conference, Vladimir Putin mentioned that the Netherlands (still) allowed the existence of a pro-pedo organization.<sup>5</sup> About a year later, in April 2014, Vereniging Martijn was banned by the Supreme Court of the Netherlands for the public-order crime of pursuing the legalization of, and trivializing, pedosexuality.<sup>6</sup> Mainstream media have been claiming for many years, and still occasionally state, falsely,<sup>7</sup> that Vereniging Martijn once gave child sexual abuse (CSA) tips and tricks. Any communication that can be (*mis*)understood as giving such tips and tricks will soon be explicitly unlawful.<sup>8</sup>

Youngsters have become more prudish; e.g. increasingly wear underwear in showers and do less topless sunbathing.<sup>9</sup> At the same time, they increasingly carry around, and assault (peers) with, knives.<sup>10</sup> Prostitutes will need to be at least 21 instead of 18.<sup>11</sup> So-called "gay meeting places" are under attack.<sup>12</sup>

## Events 2017 - 2019

- On 5 September 2017, Marthijn Uittenbogaard launched his new personal website.<sup>13</sup> It uses custom software, that was written by me.
- On 29 March 2018, news service RTL Nieuws published about the dangers and legality of a so-called "pedo handbook" that contains CSA tips and tricks.<sup>14</sup>
- On 12 September 2018, I founded charitable foundation Stichting FreeSpeechTube,<sup>15</sup> and on 10 March 2019, I (re)launched non-partisan video platform FreeSpeechTube.<sup>16</sup> The very first content that was posted by visitors were videos of scantily clad minors twerking and doing 'gymnastics'. Such content became more - too - prominent, until the boundary-pushing atmosphere forced me to intervene. On 8 January 2020, I modified the Terms of service to disallow "content with sexy and sexualized minors".<sup>17</sup> On the website, content has been published by, among others, Marthijn,<sup>18</sup> Nelson Maatman,<sup>19</sup> and me.<sup>20</sup>
- On 20 March 2019, Marthijn published an interview with Nelson on his personal website.<sup>21</sup>
- On 5 June 2019, I launched private mailing list "mnop". It had no (explicit) goal; just the requirement for participants to agree that pedosexuality should be legalized. Per my request, Marthijn announced the mailing list on his personal website.<sup>22</sup> On 5 December 2019, six months after its conception, the list was transformed into a public microblog.<sup>23</sup> Participants on the mailing list were, among others, Marthijn, Nelson, me, and - briefly - Ad van den Berg. Mails did not require pre-approval, and one of the other participants, a Russian, linked to a "pedo handbook". (Which pissed me off to no end.)
- On 17 June 2019, (personal injury adviser Yme Drost on behalf of) charitable foundation Stichting Strijd tegen Misbruik reported Marthijn and me for normalizing - or even encouraging, glorifying - pedosexuality as a close-knit group with its own network and subculture.<sup>24</sup>
- On 27 July 2019, Nelson attempted to hand out pro-pedo fliers during the Amsterdam (Gay) Pride.<sup>25</sup> The pamphlets were a protest again a decision by charitable foundation Stichting Amsterdam Gay Pride to disallow his participation. All this eventually resulted in a hearing by the Institute for Human Rights, that concluded it had no jurisdiction.<sup>26</sup> Ad, Marthijn, and me were among the audience.

- On 26 November 2019, *de Volkskrant* newspaper published an article and a podcast about the archive of Vereniging Martijn, and that Marthijn possess both it and a wiki with pedophilia-related content.<sup>27</sup>
- On 8 December 2019, Ad, Marthijn, Nelson, and me publicly announced our plan to (re)establish political party PNVD in 2020.<sup>28</sup>
- On 9 December 2019, news service RTL Nieuws claimed they had learned through months of undercover work that the "mnop" mailing list was used to share CSA tips and tricks (the linked "pedo handbook").<sup>29</sup>

## Events 2020

- On 21 January 2020, as part of a criminal investigation into the possible continuation of Vereniging Martijn, the police conducted searches and seizures in the residential houses of Ad, Marthijn (and his partner), Nelson, and me.<sup>30</sup> The Vereniging Martijn and PNVD archives, and correspondence going back many decades, were seized. Ad was arrested for possession of child pornography, and Marthijn's partner on suspicion of preparatory acts - that he did *not* do - for CSA.
- On 11 February 2020, Nelson gave a speech at the University of Amsterdam. Two days later, the university publicly apologized for inviting him and ensured it will never happen again.<sup>31</sup>
- On 13 February 2020, television series *Danny Op Straat* published an episode about Nelson and his plan to (re)establish political party PNVD, which got more than a million views on YouTube alone.<sup>32</sup>
- Less than a week later, on 18 February 2020, Nelson was arrested on suspicion of child pornography possession.<sup>33</sup>
- On 26 March 2020, the recording of a Skype call with jailed Nelson was uploaded to FreeSpeechTube.<sup>34</sup> Shortly thereafter, Nelson was banned from using Skype.<sup>35</sup>
- On 6 April 2020, *De Telegraaf* newspaper published an article about FreeSpeechTube, which is said to be part of the network and subculture of the

close-knit group.<sup>36</sup>

- On 4 May 2020, an intruder with a fillet knife who had entered Marthijn's bedroom while shouting he was about to commit murder, was driven off with a baseball bat.<sup>37</sup>
- On 7 August 2020, the PNVD was (re)established by Nelson, who had been released from pre-trial detention, and me.<sup>38</sup>
- On 28 August 2020, a petition against the PNVD was started, which received more than half a million signatures.<sup>39</sup>
- In September 2020, various demonstrations were held against the PNVD.<sup>40</sup> More are scheduled to take place later this year.
- On 2 October 2020, Mark Rutte's political party VVD expressed its desire to take away passive suffrage (i.e. the right to stand for election) from certain pedophiles.<sup>41</sup>

## Current status

Those in power want to prevent us from freely expressing our contrary opinions on pedosexuality, and have already blatantly violated many constitutionally and internationally protected human rights in an attempt to establish their goal. Just looking at the Constitution of the Netherlands, violation has occurred of prohibition of discrimination (article 1), freedom of speech (7), freedom of association (8), freedom of assembly (9), privacy (10), home inviolability (12), and privacy of communication (13).<sup>42</sup>

The Public Prosecution Service is now looking at their options to get us convicted for continuation of *the efficacy of* (Dutch: "werkzaamheid van") Vereniging Martijn, for creating an atmosphere conducive to crime, for engaging in unlawful sedition, for activities contrary to public order, and for aiding and abetting. For this, it is looking into what we discussed via, and published on, the mailing list, FreeSpeechTube, the personal website and wiki of Marthijn, the PNVD, and so on. It is completely unclear what the Public Prosecution Service will get away with. Anything seems possible.

Simultaneously, the House of Representatives is working on legislation to further curtail our basic human rights. These bills are so numerous, that I can barely keep up with them all. Among others, they include parliamentary dossiers 35079, 35366, 34650 and 32411.<sup>43</sup> I fear the upcoming Political Parties Act (Wpp) will be an outright assault

on our democracy and *rechtsstaat*.<sup>44</sup>

## Liars and hunters

During all this, we are surrounded by liars and people who turn a deaf ear. Mainstream and local media frequently lie or refuse to hear our side, their so-called "fact checkers" are whitewashing the past,<sup>45</sup> alternative media ignore us, and foreign media are not interested in our struggle. The Public Prosecution Service lies and refuses to answer (request) letters. Politicians, the police and mayors lie. The Institute for Human Rights says it may not consider our complaints; the ECHR refuses to consider them. Amnesty International refuses to answer our calls for help - they literally do not reply. Human Rights Watch does not answer. Legal authorities refuse to provide us documents. The 'local triangle' refuses to discuss - or help with - our safety, or do risk analysis. Good - sometimes lifelong - friends break ties with us, and have even testified against us. Other pedophiles, in particular from Pedofilie.nl (think Virtuous Pedophiles), publicly advocate against (listening to) us.<sup>46</sup> Some court hearings were allowed to continue without our presence, and Marthijn was denied access to his partner's hearings while mainstream media were welcome.<sup>47</sup>

In January this year, in a speech at the National Commemoration at the Auschwitz Monument, Mark Rutte mentioned "Jew hunters".<sup>48</sup> Meanwhile, threatening and chasing pedophiles has become more widespread,<sup>49</sup> and in recent months groups of "pedo hunters" have emerged.<sup>50</sup> These generally pretend to be 15-year-olds, and then lure, force statements from, or beat up, pedophiles. They share videos of their attacks on social media, such as on Facebook,<sup>51</sup> and Instagram,<sup>52</sup> generally in private but crowded groups. Last year, after a suspected CSA perpetrator was basically lynched, the Public Prosecution Service decided against prosecuting his killers.<sup>53</sup>
